Dear Governor Ferguson and Secretary Ramirez,

We are writing to respectfully urge you to preserve funding for Washington's Parent to Parent (P2P) program as the Department of Social and Health Services reviews contracts for renewal.

We understand DSHS is undertaking a broad review of contracts in response to budget guidance and that no final decision has been made regarding the Parent to Parent contract. We appreciate the difficult responsibility of ensuring taxpayer dollars are used wisely, particularly as the state faces ongoing fiscal challenges. However, we believe the Parent to Parent program represents exactly the kind of investment government should protect.

Parent to Parent provides something that government alone cannot easily replicate: experienced parents helping other parents navigate the often overwhelming journey of raising a child with developmental disabilities or special health care needs. Families receive guidance, emotional support, connections to community resources, and practical assistance from people who have walked the same path themselves.

As legislators representing parents of children who have received special education services, we understand that navigating these systems can be confusing, stressful, and isolating. Many of us are family and friends of, and advocates for the DD community, who share these concerns about the effort to eliminate this essential service. Programs like Parent to Parent

help families become stronger advocates for their children while reducing unnecessary frustration and helping connect them with the services they need.

Washington has long recognized that one of government's highest responsibilities is protecting and supporting our most vulnerable citizens. Children with developmental disabilities and their families deserve our attention, compassion, and partnership. The Parent to Parent program embodies those values by strengthening families before they reach a point of crisis.

While budget reviews are necessary, we encourage DSHS to consider not only the cost of this contract, but also its value. Investments that empower families, improve access to existing services, and provide peer support can prevent more costly interventions later while improving outcomes for children and caregivers alike.

We respectfully ask that the Parent to Parent contract be renewed and that this important program continue serving families across Washington.

Thank you for your consideration and for your continued service to the people of our state.
